OFFICIAL PROMOTIONAL RULES
Aquarius Casino Resort

The Million Dollar Deal & \$360,000 Cash Giveaway (the “Promotion”) begins on Sunday, September 20, 2026, at 12:01 a.m. and ends on Saturday, November 7, 2026, at 6:00 p.m. (the “Promotion Period”). The Promotion takes place at two (2) locations — Edgewater Casino Resort and Aquarius Casino Resort (“Participating Locations”).

The Promotion is open to eligible True Rewards® members and consists of:

- (i) seven (7) Weekly Virtual Drawings conducted at each Participating Location, awarding eight (8) participants (“Weekly Winners”) various cash prizes with one (1) of those Weekly Winners also earning an entry into the Grand Prize Drawing (“Grand Prize Finalist”); and
- (ii) one (1) final Grand Prize Selection from the combined pool of Grand Prize Finalists from both Participating Locations, for a chance to win up to one million dollars (\$1,000,000).

True Rewards® members may participate at either Participating Location. Weekly Virtual Drawings will occur at the corresponding Participating Location. The Grand Prize Selection will be conducted at Aquarius Casino Resort. Participants must be present at the time of a drawing to win.

All times referenced in these Official Promotional Rules are Pacific Time. The Promotion is sponsored and administered solely by Golden Entertainment, LLC. The Promotion is presented in partnership with SCA Gaming (“Prize Partner”). SCA Gaming’s role is limited to serving as the Prize Partner for the Promotion. SCA Gaming is not the sponsor, administrator, or operator of the Promotion and is not responsible for the collection of entries, selection of winners, administration of promotional activities, or compliance with applicable laws, rules, or regulations related to the Promotion.

1. ELIGIBILITY

Eligible Participants:

To be eligible to for the Promotion, all participants must:

- Be a current True Rewards® member in good standing;
- Be 21 years of age or older at the time of participation;
- Have a valid photo ID with a matching True Rewards® Club Card.

Ineligible Participants:

- All employees of Golden Entertainment, LLC, its advertising agencies and promotional companies involved in this Promotion, as well as family and household members of the same.
- All employees of SCA Entertainment, LP and its affiliates and their immediate family members.

2. PRIZE DETAILS

Weekly Prizes

During each Weekly Prize Promotion Period, eight (8) Participants (each a “Weekly Winner”) will be selected in the applicable Weekly Virtual Drawing at each Participating Location.

The eight (8) Weekly Prizes to be individually awarded during each Weekly Virtual Drawing at each Participating Location are as follows:

- One (1) \$10,000 USD Cash Prize **and** one (1) entry into the Grand Prize Selection;
- One (1) \$5,000 USD Cash Prize;
- One (1) \$3,000 USD Cash Prize;
- One (1) \$2,500 USD Cash Prize;
- One (1) \$2,000 USD Cash Prize;
- Two (2) \$1,000 USD Cash Prizes; and
- One (1) \$500 USD Cash Prize.

Each Participating Location will randomly select eight (8) Weekly Winners, for a total of fifty-six (56) Weekly Winners per Participating Location and a grand total of one hundred-twelve (112) Weekly Winners between both Participating Locations during the Promotion Period. Of the 112 Weekly Winners, fourteen (14) of those Weekly Winners are entered into the Grand Prize Selection (“Grand Prize Finalists”). All fourteen (14) Grand Prize Finalists will be combined into one (1) Grand Prize Selection Drawing Drum. Each Grand Prize Finalist will have an equal opportunity to be a Grand Prize Winner through the Grand Prize selection process as further described in *Section 4(b)* of these Official Rules.

Grand Prize

Between the two Participating Locations, the fourteen (14) Grand Prize Finalists will participate in the Grand Prize Selection. Each Grand Prize Finalist will have an equal opportunity to win the Grand Prize, however, there is no guaranteed Grand Prize Winner. Accordingly, there may be no Grand Prize Winner, or there may be more than one Grand Prize Winner.

The Grand Prize consists of:

- One (1) – One Million Dollars (\$1,000,000) USD in cash.

If there is more than one Grand Prize Winner, the Grand Prize will be divided equally between all Grand Prize Winners.

3. PROMOTION PERIODS

Weekly Promotion Period. Each Weekly Virtual Drawing corresponds to a separate “Weekly Prize Promotion Period,” as defined in these Official Promotional Rules. Virtual Drawing Tickets may be earned at Aquarius Casino Resort during the following seven (7) weekly periods:

1. September 20, 2026 at 12:01 a.m. – September 26, 2026 at 2:59 p.m.
2. September 26, 2026 at 3:00 p.m. – October 3, 2026 at 2:59 p.m.
3. October 3, 2026 at 3:00 p.m. – October 10, 2026 at 2:59 p.m.
4. October 10, 2026 at 3:00 p.m. – October 17, 2026 at 2:59 p.m.
5. October 17, 2026 at 3:00 p.m. – October 24, 2026 at 2:59 p.m.
6. October 24, 2026 at 3:00 p.m. – October 31, 2026 at 2:59 p.m.
7. October 31, 2026 at 3:00 p.m. – November 7, 2026 at 2:59 p.m.

Weekly Virtual Drawing Dates. Weekly Virtual Drawings will be held at 3:00 p.m. on each of the following Saturdays: September 26, October 3, October 10, October 17, October 24, October 31, and November 7, 2026 at the Aquarius Casino Resort. The Weekly Virtual Drawings on November 7, 2026, will be the last chance for one (1) Weekly Winner from each Participating Location to gain entry into the Grand Prize Selection (“Last Chance Grand Prize Finalists”). Must be present to win.

Grand Prize Promotion Period. Following the last Weekly Virtual Drawings, the Grand Prize Selection Event will be held on November 7, 2026, at 6:00 p.m. at the Aquarius Promotion Stage. Grand Prize Finalists must be present to win.

4. HOW TO PARTICIPATE

a. WEEKLY VIRTUAL DRAWINGS

1. Earning Virtual Drawing Tickets.

- Participants earn one (1) Virtual Drawing Ticket for every fifty (50) same-day Base Points earned at a Participating Location.
- There is no limit on the number of Virtual Drawing Tickets that may be earned.
- Bonus or Promotional Points, including Point Multipliers, do not count as Base Points. No points will be deducted from a participant’s True Rewards® account.
- Base Points may be earned on any denomination reel, video reel, video poker, electronic keno machine, bingo or any table game. Point earning thresholds vary by machine; refer to the True Rewards® Club for details.
- To earn points, the True Rewards® card must be properly inserted into the machine’s card reader. Sponsor is not responsible for any machine or card reader error.
- Virtual Drawing Tickets are awarded only at the Participating Location where the qualifying Base Points are earned and cannot be combined with the other Participating Location Base Points.

2. Check-In and Entry.

- Participants must check-in to their True Rewards® account on the applicable Saturday of each Weekly Promotion Period, between 2:00pm and 2:59pm to deposit earned Virtual Drawing Tickets into the Weekly Virtual Drawing Drum.

- To check in, Participants must be physically present at Aquarius Casino Resort and must insert their True Rewards® card at any slot machine located on the property.
- Once Participants have inserted their True Rewards® card, their Virtual Drawing Tickets will automatically deposit into the Weekly Virtual Drawing Drum. They must insert their card by 2:59pm.
- Any Virtual Drawing Ticket not deposited before the Weekly Virtual Drawing Drum closes will be forfeited. The Weekly Virtual Drawing Drum will be emptied after each Weekly Virtual Drawing.

3. Drawing and Winner Requirements

- Eight (8) Virtual Drawing Tickets will be randomly drawn each week during the Promotion Period. Each Participant associated with the Virtual Drawing Ticket selected in the drawing process will be designated a Weekly Winner. Participants must be present to win and may only win once per that specific Weekly Promotion Period.
- Weekly Winners will be announced at Aquarius Promotion Stage. Following announcement, each Weekly Winner must report to the Promotion Stage and present a valid photo ID and matching True Rewards® card within one (1) minute of announcement or forfeit the prize. *Participants requiring reasonable accommodation to participate may request assistance from the True Rewards® Desk or Casino Employee prior to the Drawing.*
- All Weekly Winners must complete all required paperwork to claim their prize.

4. Weekly Virtual Drawing Prize

- Each Weekly Winner will receive one (1) of the following prizes, as applicable to the Virtual Drawing Ticket selected:
 - One (1) \$10,000 USD Cash Prize **and** one (1) entry into the Grand Prize Selection;
 - One (1) \$5,000 USD Cash Prize;
 - One (1) \$3,000 USD Cash Prize;
 - One (1) \$2,500 USD Cash Prize;
 - One (1) \$2,000 USD Cash Prize;
 - Two (2) \$1,000 USD Cash Prizes; or
 - One (1) \$500 USD Cash Prize.

For clarity, the \$10,000 Cash Prize is the only Weekly Prize that includes an entry into the Grand Prize Selection.

b. GRAND PRIZE SELECTION.

1. Eligibility for Grand Prize Selection

- One (1) Weekly Winner from each applicable Weekly Virtual Drawing at each Participating Location, will receive the \$10,000 Cash Prize and entry into the Grand Prize Selection, and will be designated as a Grand Prize Finalist.
- Only the fourteen (14) Grand Prize Finalists are eligible to participate in the Grand Prize Selection.
- During the Grand Prize Selection, Grand Prize Winner(s) must present a valid photo ID and matching True Rewards® card within one (1) minute of announcement or forfeit the Grand Prize. *Participants requiring a reasonable accommodation to participate may request assistance from the True Rewards® Desk or Casino Employee prior to the Grand Prize Selection Event.*

2. Entry and Registration for Grand Prize Selection Drawing Drum

- Each Grand Prize Finalist will receive one (1) Grand Prize Entry Certificate that serves as their entry into the Grand Prize Selection (“Entry Certificate”). Each Participating Location will maintain a secure Grand Prize Selection Drawing Drum for the Entry Certificates issued to Grand Prize Finalists at that location.
- On the scheduled Grand Prize Selection Day, the seven (7) Entry Certificates from each Participating Location will be combined into one single Grand Prize Selection Drawing Drum, containing all fourteen (14) Entry Certificates issued to the Grand Prize Finalists.
- Upon arrival at the Aquarius Promotion Stage for the Grand Prize Selection, each Grand Prize Finalist must register in person at the Registration Table near the Aquarius Promotion Stage to verify their identity and presence and confirm their eligibility to participate in the Grand Prize Selection.

3. Grand Prize Selection Process

- One (1) Entry Certificate will be randomly drawn from the Grand Prize Selection Drawing Drum at a time. The Grand Prize Finalist associated with the selected Entry Certificate will be invited to the Aquarius Promotion Stage to participate in the Grand Prize Selection process.

4. Envelope Selection

- Each Grand Prize Finalist will be presented with twenty (20) unique envelopes displayed on the promotional board. Each envelope will contain a cash amount ranging from \$170 to \$250.
- The Grand Prize Finalist will select 4 out of their 20 envelopes. The amounts contained in the four selected envelopes will be added together to determine the Grand Prize Finalist’s total. If the total dollar amount in the four selected envelopes equals \$1,000, the Grand Prize Finalist will be designated as a Grand Prize Winner.
- If the total amount, in the four selected envelopes, is less than One Thousand Dollars (\$1,000), The Grand Prize Finalist will receive the total amount contained in the four selected envelopes as a consolation prize and will not be designated as a Grand Prize Winner.

5. Continuation of Selection Process.

- The Grand Prize Selection process will continue until all Fourteen (14) Grand Prize Finalists have had one (1) opportunity to select four envelopes from their promotion board.
- Each Grand Prize Finalist will have an equal opportunity and chance to become a Grand Prize Winner. A Grand Prize Winner is not guaranteed.

6. Grand Prize Requirements

- Each Grand Prize Winner must complete all required paperwork and comply with all applicable prize-claim requirements established by the Sponsor and its Prize Partner, in order to claim the Grand Prize.
- The total Grand Prize is One Million Dollars (\$1,000,000) USD in cash. If more than one (1) Grand Prize Winner is selected, the Grand Prize will be divided equally among all Grand Prize Winners.
- Each Grand Prize Winner is responsible for all applicable taxes associated with the Grand Prize.

TERMS AND CONDITIONS

1. Participation is void where prohibited or restricted by law.
2. Weekly and Grand Prizes awarded are non-transferable.
3. Voluntary participation constitutes consent for Golden Entertainment, LLC ("Sponsor") and its affiliates to use a Participant's name, photograph, and likeness for advertising and promotional purposes, without additional compensation, consideration, notice, review or consent.
4. Participants are responsible for payment of any and all taxes, licenses, registrations and other fees, as applicable.
5. Sponsor reserves the right to modify or cancel this Promotion at any time, for any reason, subject to any applicable regulatory approval, provided that such modification shall not, as of the date of such modification, materially alter or change any bonus already awarded. Sponsor may disqualify any Participants from receiving any bonus based upon fraud, dishonesty, violation of these rules or other misconduct whether or not related to this Promotion.
6. Neither Sponsor or Prize Partner, and their parents or subsidiaries are liable for injuries or losses arising or resulting from participation in the Promotion and are not liable for any acts or omissions by employees, whether negligent or willful, in the conduct of the Promotion, and are not liable in the event of any equipment or software malfunction.
7. Neither Sponsor, Prize Partner and their parents or subsidiaries are responsible for lost, late, mutilated, or illegible entries nor for electronic transmission errors or delays resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical,

hardware, software, or telephone failures of any kind, lost or unavailable connections, fraud, incomplete, garbled, or delayed computer transmissions, whether caused by Golden Entertainment, users, or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent a Participant's ability to participate in the Promotion.

8. If for any reason the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of Sponsor or Prize Partner, which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion.
9. Any attempt by any person to deliberately damage or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent of the law.
10. By entering the Promotion, each participant agrees on behalf of participant and participant's heirs, executors, and administrators (a) to release and hold harmless the Promotion Entities, Golden Entertainment, LLC, SCA Entertainment, LP, all participating locations, and each of their respective officers, directors, shareholders, members, employees and agents (collectively, the "Released Parties") from any liability, illness, injury, death, loss, litigation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from participant's participation in the Promotion and/or participant's acceptance, possession, use, or misuse of a prize or any portion thereof (including any travel related thereto); (b) to indemnify the Released Parties from any and all liability resulting or arising from participant's failure to comply with these Official Rules or a breach of any of participant's representations and warranties; (c) to hereby acknowledge that the Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, relative to any prize, including express warranties provided exclusively by a prize supplier that are sent along with such prize; (d) if selected as a winner, to the posting of participant's name on Golden Entertainment or SCA Gaming's websites and the use by the Promotion Entities of participant's name, voice, image, and/or likeness for publicity, promotional, and advertising purposes in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval, and, upon request, to the giving of consent, in writing, to such use; and (e) to be bound by these Official Rules and to waive any right to claim any ambiguity or error therein or in the Promotion itself, and to be bound by all decisions of the judges, which are binding and final. If this Promotion is administered or promoted on any social media platform, the operator/provider of such social media platform and its officers, directors, shareholders, members, employees, and agents shall be considered "Released Parties" hereunder.

Any questions or disputes concerning the interpretation of these rules or situations not covered by these rules, or in connection with the administration of this Promotion, will be resolved by Sponsor in its sole discretion and that decision shall be final and binding on all Participants. If the Participant is not satisfied with the results of Sponsor's decision, the Participant will have the option to seek resolution with the Nevada Gaming Control Board.
